FAA Cert inspection was a virtual inspection, submitted information to the FAA electronically, two corrective actions were noted, 1 was a training issue for Muncie Aviation in regards to the fueling supervisor training. There was a 12 CCM issue. The other issue was with one of the ARFF vehicles, the foam concentration on CFR 2 has a foam issue. The Foam Concentration is two Rich it was above 3%. We will need to call the manufacture to come in and retest the foam with a new technique who can do it without discharging the foam into the environment. There will have to be a discussion in the future of starting to replace the Eone in the future.
