Old Business

Property Acquisition, The Authority met in executive session prior to this meeting to discuss the interest in acquiring the White building of Muncie Aviation. Discussion was had with Muncie Aviation in obtaining a second appraisal of the property, the Authority directed the Lawyer to work with Muncie Aviation's Lawyer to discuss with an aviation related appraiser on cost and both parties have agreed to split the cost. Jim was joining by zoom with poor connection at times. Tim will reach out to him when he returns.

New Business

Tim discussed the Total Solar Eclipse, the City of Muncie and AMA are planning events on the day of April 8th, 2024. He reported that he has received a handful of phone calls from pilots interested in flying into the airport, although we have nothing planned at the airport Tim is going to advertise that people are welcome to come to the airport and watch the eclipse either from the ramp or lawn. No other events are going to be held here at this time as most vendors are set up elsewhere.

Air Craft De-icing. Tim discussed that during inclement weather the Delaware County Airport does not have the capability to de-ice aircraft. After speaking with some of the based pilots, and discussing cost to the individual aircraft owner and the cost to the airport to purchase the needed equipment and to do the modifications to the ramp. Investigating de-icing any further at this time is not cost effective. This discussion presented itself due to a Ball State Basketball flight departing out of Anderson instead of Muncie due to them having a de-icing truck. It was not needed but available.

Engineering

Jason from BF&S presented the bids for the Painting and Markings for Runway 3-21 and Taxiway B. His recommendation to the Authority is to award the project to the lowest bidder Metro Construction in the amount of \$60,770.00. Jason reports working with this company on other airport projects and has not reported issues.


Jason gave an update on other AIP projects in the works.



Wildlife Security Fence construct grant will be due in July, this will be a multi phase project hopefully just 2 but will depend on the amount awarded in the initial phase. Project estimated around 4 million. The hopes is to begin the project going north from Carl Simmons Drive and working our way around to Muncie Aviation .
